WHAT CAN EMPLOYERS DO?

- Create a tobacco-free workplace.
- Help employees to stop smoking.

Cost of tobacco cessation benefit = 10 to 40¢ per employee

Savings from cessation programs = up to \$6 for each \$1 spent

Tobacco cessation = financial returns

- Reduced health care costs
- Reduced life insurance costs
- Reduced absenteeism
- Increased productivity



















Smoking takes a toll on one's health. Yet, that only tells one side of the story.

Employees that smoke cost employers more. The CDC reports that smokers cost employers about \$3,400 per year in medical costs and lost productivity. Tobacco use is one of the leading causes of worker absence and low productivity. On average, tobacco users cost drug plans twice as much as nontobacco users. Smokers also have higher workers' compensation costs and life insurance premiums.

Covering tobacco cessation treatment in your company's health plan is the most cost-effective health insurance benefit you can provide for your employees. Research shows a positive return on investment within the first year the cessation program starts. Most cessation programs cost less than .50 per employee per month. In contrast, treating one case of lung cancer can cost thousands of dollars.

Tobacco cessation programs make sense for Mississippi businesses. Providing a cessation benefit in your company's health plan, making your workplace tobacco-free, and encouraging your employees to use the Mississippi Tobacco Quitline will improve your business and your bottom line.
